1. Does the municipality have a functional website? Does the website have a dedicated page for procurement information, which can be accessed without registration?


- Yes, the municipality has a functional website with a dedicated page for procurement information, and this information can be accessed without registration.
- Yes, the municipality has a functional website but the website has no procurement information or the municipality has a functional website with a dedicated page for procurement information but registration is required to access this information.
- No, the municipality does not have a functional website.

Comments:

- The municipal website has a tab for tenders.
- However, clicking on this tab leads to closed tenders.
- Effectively, the municipality only publishes closed tenders. Even then, the list of closed tenders is incomplete. They are all tenders that closed on 03 April 2018.
- To see if there were any other tenders, one must search 'tenders' using the municipal search engine. This search engine eventually leads to 'supply chain management contracts'. This section provides a combination or mixed bag of information on tenders, inclusive of: a list of bids that are closing on a particular date; a bid register capturing a list of bidders for a particular tender; and here and there, awarded tenders



2. Does the municipality publish tender notices?


- a. Yes, the municipality publishes tender notices and the list of tender notices seems complete.
- b. Yes, the municipality publishes tender notices but the list of tender notices has obvious gaps or the list seems incomplete.
- c. No, there are no tender notices on the municipality's website.

Comments:

- To see if there were any other tenders, one must search 'tenders' using the municipal search engine. This search engine eventually leads to a tab 'supply chain management contracts', which yields the mixed bag shown below:
- According to the list, the last advertised tender was in September 2019.
- The eTender portal does provide for municipal tenders however.

3. Does the municipality publish tender specifications for tender notices on its website, can they be downloaded free of charge?


- a. Yes, the municipality publishes tender specifications on its website, which are downloadable free of charge.

Comments:

- After navigating the municipality's website, there is no obvious link to active tenders.
- A 2019 link on "adverts to be closed" indicates that the municipality did advertise previously. However, it only listed tenders, with an indication that the public can go to the municipal offices to obtain documentation. See Annex 1
- In this document, there is also an indication of a fee charge of R300.
- The e-tender portal advertises active municipal tenders <https://etenders.treasury.gov.za/content/provision-layout-production-and-delivery-re-dira-megazine-period-36-months-0>. For one tender, it indicates that a fee of R1000 will be charged for tender documentation <https://etenders.treasury.gov.za/content/advertised-tenders>. 


Lists provide for :

Contract Description, Successful bidder, contract price, reason for award (e.g. bidder obtained highest points in terms of PPFFA), highest bidder amount, HDI status, closing date, appointment dated, number of days taken to appoint.

- The national treasury e-portal does publish information on who was awarded tenders. It also publishes the price.

5. Do tender specifications remain accessible on the website after the contract has been awarded for the duration of the contract?

- Yes, the tender specifications remain accessible on the website after the contract has been awarded for the duration of the contract.
- Yes, the tender specifications remain accessible on the website after the contract has been awarded but not for the entire duration of the contract or not all tender specification information remains accessible on the website for the entire duration of the relevant contracts.
- No, the tender specifications are removed after the award of the contract or the municipality does not publish tender specifications.

6. Does a municipality publish the price of the contract?


- Yes, the municipality publishes the price of the contract.



- It also publishes the price. However, this (publishing of price) is not done for all tenders. This is shown on the two graphics below, for the Financial Year 2020/21.



Contract Value is



- No, the municipality does not publish procurement information on either its website or the eTender portal.



Comments:

- The ePortal is more reliable on tender information than the municipal website. The municipality does not even direct users to the ePortal, at the very least.
- An important note is that since the last assessment, it is a new development that the ePortal has information on the municipality's active tenders. That said, it is also possible that at the

time of the last assessment, there were no active tenders, and not necessarily implying that the ePortal did not contain this information at all.



General assessment:

a) What is your overall impression on how easy it is to navigate the municipal website to find procurement information? Rate out of 10?

- It was not easy to navigate this website for the purpose of procurement information.
- The fact that there is no tab for active tenders was problematic, and one was left wondering whether it is hidden somewhere. **5/10**

b) Any tips on how the municipality could improve citizens' access to procurement information on its website?

- Have a clear tab for active tenders
- Provide a link to the ePortal of National Treasury, as a minimum.

c) Are there any best practices in the municipality which can be shared with other municipalities?

- When the municipality did publish awarded tenders, its publication was very useful to the extent that it provided for 'reason to appoint' and 'number of days taken to appoint'. These are all good indices in terms of measuring transparency and efficiency, respectively.

d) Are there any other issues that caught your attention when undertaking the assessment?

- It is difficult to contemplate why the municipality is not advertising active tenders and awarded tenders, even under the COVID-19 conditions where there are calls for transparency. It almost seems brazen, given that the North West province has been under such scrutiny, from a financial management and governance standpoint. Then again, this makes a case for why the province is not doing well on municipal financial governance.

The tenders will also be evaluated based on the experience, capacity and references where relevant. If you do not hear from us after the expiry of the validity period please accept that your bid is unsuccessful. Please note that it is a requisite of the municipality that all suppliers must be registered on the database of the municipality and Central Suppliers Database (CSD), therefore all bidders who are not registered on the database system must ensure that their bids are accompanied by the database forms.
