- a. Yes, the municipality publishes information about who wins tenders within five working days.
- b. Yes, the municipality publishes information about who wins tenders but after five working days or the list of names of companies or individuals who won the tender has obvious gaps or seems incomplete.
- c. No, the municipality does not publish information about who wins tenders.

In addition to the names of those who won the tenders, the municipality also publishes the names of those who bid for the tender but were unsuccessful. Reasons why those bids were unsuccessful are also provided on the municipality's website.

5. Do tender specifications remain accessible on the website after the contract has been awarded for the duration of the contract?

- a. Yes, the tender specifications remain accessible on the website after the contract has been awarded for the duration of the contract.
- b. Yes, the tender specifications remain accessible on the website after the contract has been awarded but not for the entire duration of the contract or not all tender specification information remains accessible on the website for the entire duration of the relevant contracts.
- c. No, the tender specifications are removed after the award of the contract or the municipality does not publish tender specifications.

- Yes, the municipality publishes information on how the project will be implemented.

 - No, the municipality does not publish information on how the project will be implemented.

Comments: The Msukaligwa local municipality did not publish procurement information on the eTender portal for the time period that is covered by this research. The municipal website however publishes procurement information for the time period covered by this study. Nevertheless, it is important to note that the Msukaligwa municipality has procurement information on the eTender portal but this was published in October 2020.

General assessment:

- a) What is your overall impression on how easy it is to navigate the municipal website to find procurement information? Rate out of 10?

It was easy to navigate the municipal website because the tender tab can be accessed directly from the home page. Furthermore, all the procurement information is accessed from that tender page. One does not have to get the information from different places. I would rate the website a 10/10 for easy navigation.

- b) Any tips on how the municipality could improve citizens' access to procurement information on its website?

The municipality can improve citizens' access to procurement information by improving the speed to which one can download their documents as well as clearly providing the prices for the contracts and not just percentages.

- c) Are there any best practices in the municipality which can be shared with other municipalities?

One best practice that can be shared with other municipalities would be how the Msukaligwa website not only publishes the name of companies or individuals who won the tenders but also the names of companies and individuals whose bids were unsuccessful and the reasons why these parties were not awarded the tenders.

- d) Are there any other issues that caught your attention when undertaking the assessment?

A noteworthy issue that caught my attention would be how it took me close to 4 minutes to download a 32MB pdf file.
